- Activity Ads and Sponsorship Presentation Mr. Shupp
 - Aimed at creating a sustainable partnership between Treynor Community Schools and local businesses to enhance student athletics and activities through increased resources and collaboration.
 - Developed structured levels of sponsorship with benefits ranging from digital ads to physical signage, ensuring businesses gain visibility through platforms like Bound, Huddle, and social media.
 - Utilizing the Bound platform, which recorded 400,000+ views last year, allows businesses to feature clickable ads that link directly to their websites. Live score updates also promote sponsors.
 - Initial plans include physical signage for sponsors at events, with a long-term goal of transitioning to digital video boards for a cleaner look and more dynamic engagement.
 - Plans to involve coaches, teachers, and community members in promoting the program to maximize outreach and participation.
 - Opportunities for students to contribute by creating marketing content, hype videos, and managing digital elements like video boards.
 - Plans to add video boards and interactive features to further integrate sponsors and enhance the game-day experience.

 - Technology Report Board Update- Mrs. Bailey
 - High school and middle school upgrades are nearly complete; elementary upgrades are to begin soon.
 - New access points offer faster, more reliable connections with advanced technology.
 - Proposal to equip remaining elementary classrooms with interactive ClearTouch panels to replace aging projectors.
 - Panels provide interactive features, wireless projection, and cost-effectiveness, with adjustable carts for flexibility.
 - Comprehensive vulnerability scanning by a vendor to assess and mitigate risks.
 - Focus on documentation and procedures for cybersecurity insurance compliance.
 - Efforts to maintain a secure internal network and minimize vulnerabilities.
 - Transitioning teachers from Windows laptops to Chromebooks for enhanced security and ease of use.
 - Reallocating replaced Chromebooks to paraeducators for efficient resource utilization.
 - Identified as a future project due to the aging technology, with plans to ensure long-term reliability.
 - Preparing for potential price increases on technology purchases due to tariffs and supply chain issues.

 - Policy and regulation were reviewed by DLT members and BLT members for review and input. From there a sub-committee has been created with Mr. Hansmann, Mrs. Bailey, Mr. Nickerson and Dr. Beyenhof for the final review of the policy and regulation. The recommendation is to adopt the model policy and

regulation from IASB and work on more specific language for the student handbook the covers topics such as: plagirism, citation, using AI for drafting, personal data protection, bully/harassment, etc. This additional language will also be reviewed by the DLT and BLT, but for now the recommendation is to adopt the policy and regulation.

- Discussion and Action Items
 - Review Bid for Field Turf Replacement
 - The project bid was awarded to **Midwest Field Turf** for \$540,510, which is under the estimated budget of \$593,000.
 - The proposal includes the complete removal and replacement of the field turf with top-quality materials and updated design features.
 - Annual deep-cleaning services are included for the duration of the 8-year warranty.
 - \circ $\;$ Sustainable practices, such as reusing quality infill material, to minimize waste.
 - Addition of infrastructure for play clocks, including conduits and junction boxes.
 - Field Turf was chosen for its proven performance, excellent customer service, and positive history with the district's current turf.
 - The bid includes all necessary components for installation, ensuring compatibility with existing systems.
 - The project is scheduled for summer 2025, with work anticipated between **June 9** and **July 18**.
 - The timeline is tight, and the district will ensure the contractor adheres to the schedule.
 - The project will be funded through **SAVE** funds, which are generated from the statewide sales tax.

 - HVAC Control Elementary
 - The bid was awarded to Engineered Controls for \$173,680.
 - This vendor was chosen due to their comprehensive proposal, which includes replacing all wiring, sensors, and control modules, ensuring a complete overhaul of the system.
 - Removal and replacement of old wiring, sensors, and control modules to address current operational issues.
 - The project includes updates to actuator valves, which are still operational but will benefit from compatibility with new controls.
 - The new system will provide improved functionality and reliability.
 - Engineered Controls has an established relationship with the district, having successfully implemented controls for the middle school and high school additions.
 - The proposal focuses on ensuring compatibility with future upgrades and includes Honeywell controllers, which are widely supported and not proprietary.
 - Work is scheduled to begin on **June 2**, **2025**, to align with summer schedules and minimize disruptions.
 - The goal is to complete the project before the start of the next school year, allowing for operational testing and adjustments.
 - Enhanced reliability and efficiency of the HVAC system.
 - Better control over building climate, leading to energy savings and improved comfort for students and staff.

- At-Risk/Dropout Application
 - The application requests funds to support programs aimed at reducing dropout rates and addressing the needs of at-risk students in the district.
 - The district is requesting the **maximum allowable amount of \$113,223** in Modified Supplemental Amount (MSA).
 - The district is required to match **\$37,741**, resulting in a combined total of **\$150,964** for the program.
 - Funds will primarily be used for:
 - Salaries of intervention specialists and support staff.
 - Programs and initiatives targeted at student retention.
 - Services addressing the social, emotional, and academic needs of at-risk students.
 - Personalized support for at-risk students through counseling and mentoring.
 - Implementation of evidence-based strategies to improve academic outcomes.
 - Focus on early identification of students needing intervention.
 - Provision of additional resources to help students meet graduation requirements.
