- Activities Report – Jason Shupp presented
 - Summer Recap
 - Baseball – 14–12 record, substate semifinalists; multiple WIC and all-district honors.
 - Softball – Regional championship appearance; multiple all-state, all-district, and WIC recognitions.
 - Fall Preview
 - Football – 48 players; turf installation complete; toughest schedule in 25 years; strong returning skill players.
 - Volleyball – 34 players; focus on team bonding and WIC/state goals.
 - Cross Country – Girls aiming for another state podium finish; first meet Aug 26.
 - Marching Band – New show *The Art of Motion* debuting Sept 12 at halftime of home football game.
- Elementary School Report - Jill Kay Presented
 - New Behavior Framework – Launching CHAMPS program to create consistent, building-wide expectations for student behavior, making transitions between classrooms smoother for students. PD kickoff scheduled for Aug. 19 with training led by building leadership team members who attended a June conference in Des Moines.

• MS/HS School Report – Mr. Nickerson Presented

- Enrollment – Increased from 468 last year: strong incoming 6th-grade class with continued open enrollment interest.
- New Staff –
 - Jennifer Johnson – 7th Grade English/Reading
 - Ms. Harris – 8–9 English; serving as mentor to Johnson.
- Orientation Nights – 6th and 9th grade events set; focus on building connections before the first day.
- Cell Phone Policy – Implementing new state requirement: no phones during instructional time; pocket charts in classrooms; allowed during lunch and passing periods for HS students.
- AI Policy – Teaching responsible, academic use of AI; integrating guidance into curriculum while blocking unrestricted access to AI tools.
- First Week Prep – Five consecutive days of school to start; emphasis on routines, expectations, Chromebook distribution, and early activities (volleyball, football, cross country).

• Director's Report – Dr. Beyenhof presented

- Business, Technology, Nutrition, Facilities, and Maintenance – All departments reported being on track for the start of the school year.
- Updates included finalizing summer projects, ensuring technology readiness, preparing nutrition services for meal service on day one, and completing cleaning/maintenance schedules.
- No major concerns or delays reported.

Discussion / Information / Review Items

• Signage for Visitor Parking – The Beautification and Signage Action Committee requested clearer visitor parking signage to direct guests to the football and soccer fields.

- Suggestions included temporary sandwich boards or permanent way-finding street signs near Highway 92.
- Goal: Reduce congestion on big event nights and guide traffic to the designated visitor lot.
- The administration will work with the City of Treynor to explore options and possible cost-sharing.

• First Reading of Policy 501's and 502's

- Reviewed 500 Series policies as part of this year's scheduled policy review.
 - Discussion items:
 - 501.4 (Entrance/Admission) – Question raised about kindergarten admission language; administration to clarify with IASB model policy guidance.
- 501.10 – Recommended for elimination due to redundancy; content is already addressed in other updated policies.
- Numbering will remain aligned with IASB's model for consistency.
- No formal action taken; changes will return for second reading and approval at a future meeting.

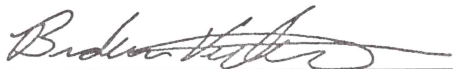
