 1. SSA increase proposals range from 2% to 2.25%. Bills aim to change the school start date, but passage is uncertain. A proposal may allow the management levy for retention. Operational sharing discussions continue. Many education bills are in play. Preschool funding remains a concern, with advocacy for full-time funding.

 1. The school is hiring seasonal workers for cleaning (\$15.50/hr), grounds (\$16/hr), and painting (\$16-\$18/hr). Efforts focus on recruiting high school and college students to ensure full coverage. To avoid last year's turnover issues, early planning, referrals, and flexible scheduling will be key.

2. MOU with Family Connections
 1. MOU
 1. This agreement represents Family Connections providing a therapist 6 hours per week.
 1. The (MOU) with Family Connections is designed to enhance mental health support at the elementary level by providing on-site therapy services. A therapist would be available regularly, such as once a week, to work with students needing more intensive support. The cost is \$70 per hour, but if the therapist can bill insurance or Medicaid, the school would not bear the cost. This initiative aims to address deeper mental health challenges, particularly those related to trauma, by offering professional therapeutic interventions.
