Call to Order & Roll Call

President Vorthmann called the regular meeting to order at 6:30 p.m., and roll was taken. The following board members answered roll call: President Vorthmann, Vice President Stogdill, Mr. Christensen, and Mr. Dreyer. Director Winchell was absent.

Amend and/or Approve Agenda

A motion was made by Stogdill, seconded by Dreyer, to approve the agenda. Motion carried 4-0.

Reports and Communication Items

Ms. Kay, Elementary Principal, reported: 1) With the last day of school approaching, there are several student events planned, such as field trips and the annual field days. 2) The TS Bank Cardinal Branch has had a successful year, meeting the goal of 25% of students participating. 3) The TeamMates Program is sponsoring a bowling night for mentors and mentees on May 17th. 4) The fifth grade class will visit the middle school this week and we will hold a 5th grade graduation on May 20th.

Mrs. Berens, Middle School Principal, reported: 1) Two Middle School TAG teams participated in the Battle of the Books competition. 2) Computer Science will be a required subject in middle school and elementary beginning with the 2023-2024 school year. Randi Endriss, TAG instructor, and Jen Nelson, Librarian, will both be attending some classes this summer to prepare. Mrs. Endriss will incorporate computer science into TAG and Mrs. Nelson will teach computer science as an exploratory to 7th grade students beginning with the 2022-2023 school year. 3)Junior High girls and boys track were WIC champions.

Mr. Hedger, High School Principal, reported: 1) Treynor Day of Caring at Open Door Mission was held April 19th. This annual event is a terrific opportunity

for students and staff members to give their time and talents to help others. 2) Mrs. Behrendt's Career Readiness students participated in mock interviews and job shadows over the course of the semester. It is a great learning opportunity. 3) Fifteen Treynor HS students attended Career Day at the Iowa State Fair grounds. It was a great handson learning experience for the students interested in vocational pursuits. 4) May is all about celebrating the Class of 2022. They will be busy with senior trip, awards night, baccalaureate, their last day at Treynor High School, and graduation day on May 15th.

Discussion/Information/Review Items

ACHIEVE Special Education System

Iowa school districts are moving to a new special education documentation system called ACHIEVE, with Treynor beginning the move to the new system in June 2022. Ms. Kay, as special education administrator, will lead the district in implementing the system with the help of the Iowa Department of Education and Green Hills AEA.

Inter-District Transportation Agreement for 2022-2023

Iowa Code 285.9 requires each Area Education Agency Board of Directors to review all transportation agreements between districts in the AEA. The agreement for 2022-2023 outlines reasons Treynor and neighboring districts may drive school buses into each other's district. Neighboring districts include Riverside, Underwood, Glenwood, Lewis Central, East Mills, and Council Bluffs.

Teacher/Paraeducator Apprenticeship Grant Application

Twenty-one school districts in the southwest corner of Iowa are joining forces to address the lack of quality paraprofessional and teacher candidates. The Southwest Iowa Consortium of Rural Schools (SICRS), in an effort to address the increasing inability to adequately staff our schools with paraprofessionals and teachers and the knowledge that fewer people are selecting the teaching pathway, believe it is vital for us to "grow our own." The purpose of the grant application to Iowa Workforce Development is to secure the monetary support needed to assist current employees and high school students who are interested in making education their chosen profession. Green Hills AEA will serve as fiscal manager for the grant. Academic partners include Iowa Western Community College, Southwest Community College, William Penn University, and Western Governors University.

School Leader Update

The School Leader Update is a newsletter published by the Iowa Department of Education that includes a variety of timely topics, issues, and deadlines. Board members received a link to the Spring 2022 newsletter.

Action Items

AEA Social Worker Agreement for 2022-2023

A motion was made by Christensen, seconded by Dreyer, to approve the AEA Social Worker Agreement for 2022-2023. This agreement stipulates the services of a Master Social Worker, provided by Green Hills AEA, 76 days during the 2022-2023 school year at \$347.87 per day, plus associated travel. The Treynor District has utilized this service since the 2019-2020 school year. Motion carried 4-0.

Buena Vista University Student Field Experience Agreement

A motion was made by Stogdill, seconded by Dreyer, to approve the Buena Vista Student Field Experience for 2022-2025. This agreement allows collaboration between Buena Vista University and Treynor School District in providing students in the education department at Buena Vista the opportunity to complete all field experiences, practicums, and student teaching at Treynor. Motion carried 4-0.

Auditor Bid Proposals for 2022-2024

A motion was made by Dreyer, seconded by Stogdill, to approve the auditor proposal from Schroer & Associates to audit the financial statements for the years ending June 30, 2022, 2023, and 2024. Cost of the annual independent audit, required by Iowa Code, will be \$9,000 per year. Schroer & Associates has been satisfactorily auditing the records of Treynor School District since 2019. Motion carried 4-0.

Activity Driver Pay Rate Increase

A motion was made by Stogdill, seconded by Dreyer, to approve an activity bus driver pay increase of \$2.00, raising the hourly rate to \$15.00, beginning June 1, 2022. This will put the activity rate in line with other bus driver rate increases made during the year and will assist the district in ensuring there are drivers for the summer sports season. Motion carried 3-0, with Christensen abstaining because he occasionally drives activity trips for the district.

Early Graduation Requests

A motion was made by Christensen, seconded by Stogdill to approve the early graduation requests for Samantha Leazenby and Connor Graybill. These two juniors and their parents have worked with Mr. Hedger and Mrs. Floerchinger to assure all parties agree with the early graduation. Motion carried 4-0.

Personnel

Resignations

A motion was made by Dreyer, seconded by Christensen, to approve the resignations of 1) Jacob Hedger as high school principal; 2) Thad Nelson as high school math teacher; 3) Heather Behrendt as middle school math teacher; 4) Clark Allen as high school social studies teacher; 5) Jackie Konz as middle school social studies teacher/paraeducator; 6) Dana Boswell as elementary secretary; 7) Penny LeVier as elementary cook; 8) Jeff Koenck as high school student council sponsor; and 9) Tom Trede as bus driver/transportation director (activity scheduler). President Vorthmann spoke for the entire board in thanking them for their service to Treynor students and the Treynor School District. The motion was approved on a 4-0 vote.

Employment

A motion was made by Stogdill, seconded by Dreyer, to approve employment for Dr. Joel Beyenhof as Superintendent, to begin July 1, 2022. Several community members and staff participated in superintendent interviews on May 2, 2022, with Grundmeyer Leader Services coordinating the search. Motion carried 4-0.

A motion was made by Christensen, seconded by Dreyer, to approve contracts/agreements as presented for: 1) Charity Pearce as middle school math; 2) Ryan Stumbo as high school social studies; 3) Taci Beam as 5-12 instrumental music; and 4) Katrina Hobart as middle school/high school English/language arts. Motion carried 4-0.

A motion was made by Stogdill, seconded by Christensen, to approve employment for: 1) Courtney Lovely as elementary/middle school paraeducator (math interventions); 2) Annette Koehler as bus driver (regular route); 3) Mike Shannon as summer grounds maintenance; 4) Bob Beattie as summer grounds maintenance; 5) Ron Zimmerman as summer custodian; 6) Cory Young as summer custodian; and 7) Melanie Schuler as summer custodian. Motion carried 4-0.

A motion was made by Christensen, seconded by Dreyer, to approve employment for: 1) Madelyn Deitchler as assistant softball; 2) Josh Weis as assistant baseball; 3) Lea Crouse as head high school volleyball; and 4) Jacob Beresh as junior high boys' basketball. Motion carried 4-0.

Facilities and Grounds Updates

Superintendent Hopkins provided an updated list of items ongoing, in progress, and completed recently. Summer projects include painting the east gym, refinish the east gym floor, painting several elementary classrooms and east hallway, paint and carpet old art room, new ceiling tile in the lower MS/HS hallways, fence for new addition driveway near softball field, and move concession area to current middle school work room (this project is in collaboration with the Treynor Booster Club).
