The Board of Directors of the Treynor Community School District met in regular session on Monday, October 16, 2017, 6:30 p.m., in the MS/HS Library, located in Middle School Building, 102 E. Main St., Treynor, IA 51575.

Call to Order & Roll Call

President Graber called the regular meeting to order at 6:30 p.m., and roll was taken. The following board members were present: President Graber, Vice President Funkhouser, Guttau-Fox, Schnepel and Myers, who participated via telephone.

A motion was made by Schnepel, seconded by Funkhouser, to adjourn the meeting. Motion carried 5-0.

Organizational Meeting

The Superintendent, as president pro-tem, called the meeting to order and roll call was taken. The following board members were present: Amy Graber, Heidi Guttau-Fox, Sally Myers via telephone, and incoming members Mickey Stogdill and Brandon Vorthmann.

Oath of Office

Board Secretary VanFosson administered the oath of office to Mickey Stogdill and Brandon Vorthmann. They will each serve a four year term.

Election of President

President Pro-Tem Howell asked for nominations for the office of President of the Board of Directors. Guttau-Fox nominated Amy Graber to serve as President of the Board of Directors for 2017-2018 and Graber was elected on a unanimous vote. President Pro-Tem Howell administered the oath of office to Amy Graber and she assumed the duties of president.

Election of Vice President

President Graber asked for nominations for the office of Vice President of the Board of Directors. Stogdill nominated Heidi Guttau-Fox to serve as vice president of the Board of Directors for 2017-2018 and Graber nominated Sally Myers to serve as vice president of the Board of Directors for 2017-2018. A roll call vote was taken: Vorthmann-Heidi Guttau-Fox; Stogdill-Heidi Guttau-Fox; Guttau-Fox-Heidi Guttau-Fox; Graber-Sally Myers; and Myers-Sally Myers. Guttau-Fox was elected vice president on a 3-2 vote. The oath of office was administered to the new vice president by President Graber.

Open Forum

No visitors chose to address the board during the open forum.

A Mini-Lesson in Finances

Board secretary VanFosson reviewed the "funds" the school district uses for revenues and expenditures, explaining Iowa Code dictates how each fund is used. She also explained school districts track financial standing in the general operating fund in two ways – cash (how much is in the bank) and budget authority (how much the district is authorized to spend-similar to a credit card limit).

It's All About the Learning

Elementary music teacher Michael Stinman demonstrated the educational process he's using with the fourth grade class to grasp the concepts of pitch and the position of notes on the music staff. Eight of his fourth grade students worked with board members on a fun learning activity.

Establishment of Dates/Times/Places for Regular Meetings of the Board

A motion was made by Vorthmann, seconded by Stogdill, to continue meeting the second Monday of each month, at 6:30 pm, in the board room next to the superintendent's office in the high school. Motion carried 5-0.

Board Resolution to Define the Operating Rules and Practices That Will be Followed by the New Board

A motion was made by Guttau-Fox, seconded by Myers, to continue the use of Robert's Rules of Order at each meeting. Motion carried 5-0. The Rules of Order Regulation (per Board Policy 211.7R1) state:

1) Board members need not rise to gain the recognition of the board president. 2) All motions will be made as a positive action. 3) A motion will be adopted or carried if it receives an affirmative vote from more than half of the votes cast. Only "yes" and "no" votes are counted in this calculation. It should be noted that some motions require larger numbers of affirmative votes, such as to move into a closed session. 4) All motions shall receive a second, prior to opening the issue for discussion of the board. If a motion does not receive a second, the board president may declare the motion dead for lack of a second. 5) The board president may decide the order in which board members will be recognized to address an issue. An attempt should be made to alternate between pro and con positions. 6) The board president shall rule on all motions that come before the board. 7) The board president may rule on points of order brought before the board. 8) The board president shall have complete authority to recognize a member of the audience regarding a request to participate in the board meeting. Members of the public who wish to participate shall follow board policy. 9) The board president has the authority to declare a recess at any time for the purpose of restoring decorum to the meeting. 10) The board president has the same authority and responsibility as each board member to vote on all issues.

Appointment of Legal Counsel for the School District and the Board

A motion was made by Guttau-Fox, seconded by Myers, to continue utilizing the services of Brett Nitzschke of Lynch Dallas, P.C. as primary counsel and Susan Sapp of Cline Williams Wright Johnson & Oldfather, L.L.P as Title IX attorney. Motion carried 5-0.

Allowable Growth Request for FY'17 Special Education Deficit

A motion was made by Guttau-Fox, seconded by Vorthmann, to request allowable growth and supplement aid for a negative balance in special education for the 2017 fiscal year. The district spent \$142,152 more in special education services than what was received in dedicated special education revenue. Motion carried 5-0.

Open Enrollment

A motion was made by Stogdill, seconded by Guttau-Fox to approve the open enrollment applications from 4 students (two families) who have moved out of the Treynor District but wish to continue education in the district. Motion carried 5-0.

Personnel

A motion was made by Guttau-Fox, seconded by Stogdill, to approve the following personnel contracts: Michelle Osborn – special education driver, Traci Black – wrestling cheerleading coach, and Jim Lovely – 9^{th} grade boys' basketball coach. Motion carried 5-0.

Early Graduate Request

A motion was made by Myers, seconded by Guttau-Fox to approve the early graduate request from Josh Honig. Motion carried 5-0.

Instructional Support Levy Resolution

A motion was made by Vorthmann, seconded by Stogdill to approve the Resolution of Intent to continue participation in the Instructional Support Program. Motion carried 5-0 and the Resolution was adopted as follows:

WHEREAS, the Board deems it necessary and desirable to provide additional funding for the Treynor Community School District pursuant to the Instructional Support Program; and

WHEREAS, in order to consider continued participation in an Instructional Support Program, the District must hold a public hearing on the question of participation, setting forth its proposal following publication of the notice of the time and place of such hearing; and

WHEREAS, the Board wishes to set forth in a Resolution its proposal specifying the method and amount to be used to fund the continuance of the Instructional Support Program, the purposes within the general fund for which the Instructional Support funds will be used, set a date of public hearing, and direct the Board Secretary to publish notice of the time and place of hearing;

NOW, THEREFORE, be it resolved by the Board of Directors of the Treynor Community School District, in the Counties of Pottawattamie and Mills, State of Iowa, as follows:

<u>Section 1</u>: A public hearing on the question of the Treynor Community School District's continued participation in the Instructional Support Program is hereby set for November 13, 2017 at 6:30 o'clock p.m. in the Treynor Community School District Middle/High School Library, 102 East Main Street, Treynor, Iowa, and the Secretary of the Board is hereby authorized to give notice of the time and place of the public hearing by publishing said notice in the *Neola Gazette* not less than ten (10) nor more than twenty (20) days before the date of the public hearing.

Section 2: At the public hearing the Board will announce the date, no longer than 30 days after the hearing, on which it will take action to adopt a resolution to participate in the continuance of the Instructional Support Program. At the public hearing the following proposition, as may be modified as a result of discussion and input, shall be considered for inclusion in the resolution to participate in the program, to wit:

The Board of Directors of the Treynor Community School District in the Counties of Pottawattamie and Mills, State of Iowa, does hereby resolve to participate in the continuance of the Instructional Support Program for a period of five (5) years, to levy annually, as determined by the Board, an instructional support property tax which will be levied annually upon the taxable property within the District, commencing with the levy of property taxes for collection in the fiscal year beginning July 1, 2018, and an instructional support income surtax imposed annually for each budget year, the percent of income surtax (not to exceed ten percent (10%)) to be determined annually by the Board for each budget year to be imposed upon the state individual income tax of each individual income taxpayer resident in the District on December 31, 2018, and each year thereafter.

The funds thus collected, when combined with Instructional Support State Aid, shall not exceed ten percent (10%) of the regular program district cost, including the budget adjustment pursuant to Iowa Code section 257.14 for any budget year. Instructional Support Program funds may be used for the purpose of technology, instructional materials, curriculum, transportation needs, maintenance and related equipment, debt reduction, and improvements to sites, facilities, equipment, and furnishings.

<u>Section 3</u>: All resolutions or orders or parts thereof in conflict herewith be and the same are hereby repealed to the extent of such conflict.
